In terms of section 75A of the Local Government: Municipal Systems Act, no.32 of 2000 that the Thabazimbi Local Municipality, at a meeting held on 31 May 2016, resolved to approve all budget related tariffs with effect from 1 July 2016, for increased costs on Supply of Electricity; Water Services, Sewerage Disposal Services, Waste Management Services, Cemeteries, Hiring of facilities and related service provisions;;
