Acceptable proposals will be evaluated by using **90** /10 system that awards points on the basis of points for meeting the specific goals (**90**) and proposal price (**10**) on criteria as per the guidelines, in accordance with the Preferential Procurement Policy. The B-BBEE score card will be used to allocate preferential points.

Tender documents will be made available from the 12th July 2013 at the Thabazimbi Local Municipality, Procurement Offices at a non refundable fee of R220.00 per set. Please note that Tender documents will not be faxed or e-mailed to bidders.

A VALID ORIGINAL OR CERTIFIED COPY OF A COMPANY'S TAX CLEARANCE CERTIFICATE MUST BE SUBMITTED WITH THE PROPOSAL DOCUMENTS.

Proposals and supporting documents must be sealed and externally endorsed with the **PROPOSAL NUMBER AND PROJECT DESCRIPTION** and must be placed in the Tender box at the Thabazimbi Local Municipality offices, 7 Rietbok Street, Thabazimbi not later than 26 July 2013. All proposals shall hold good for **90 days** as from the closing date of proposals.

Conditions of tender:

- 1. No late tenders will be considered.
- 2. Thabazimbi Local Municipality reserves the right not to accept any tender.
- 3. The bidders will be invited to make presentations on their shopping complex concepts/models.
- 4. The proposed purchasing amount will be shown by the bidders in their bids.
- 5. The results will be announced at a later date.

Qualifying criteria:

- Valid tax clearance certificate/exception SARS tax clearance (tax Clearance should be valid for 120 days after the closing date)
- Certified copy of registration (entity)
- Copy of resolution to authorize signatory of tender documents
- Certified ID copy of the authorized person to sign tender document
