PUBLIC NOTICE / PUBLIEKE KENNISGEWING

UPGRADE OF THABAZIMBI AND REGOROGILE BULK WATER SUPPLY AND ASSOCIATED INFRASTRUCTURE

Thabazimbi Local Municipality has commenced with a water sustainability and water quality improvement project on the bulk water supply network with funding received from Department Water and Sanitation under the WSIG programme. The construction activities for the bulk water project for Thabazimbi and Regorogile will, amongst others, include:

- pressure zone isolation,
- installation of Pressure Relieve Valves (PRV's),
- installation of isolation valves.
- · installation of zonal bulk meters, and;
- upgrading of bulk water pipelines where required.

These bulk water improvement activities is necessary to ensure all areas within Regorogile and Thabazimbi receive continuous and good quality water and furthermore will ensure that water stoppages and water losses are reduced to the minimum.

Tentative program that can change following construction activities

13 th Avenue	7 September 2020	26 October 2020
Hamerkop Street	10 September 2020	11 November 2020
Frikkie Meyer Street	22 September 2020	3 December 2020
Watsonia Street	2 November 2020	14 January 2021
Van Der Bijl Street	1 December 2020	24 February 2021
Eland Street	25 February 2021	31 March 2021

Residents are also advised on the following:

- 1. Dust at the affected streets (which will be controlled by the Contractor's Safety Agent).
- 2. Removal of Paving and vegetation (inclusive of gardens) or other relevant obstructions in the pipeline route which will be reinstated during the course of construction or once construction activities have been completed i.e. pressure testing.
- Road Crossings will be done, resulting in Stop & Go signage OR closing of streets and redirecting traffic, vehicle stoppages resulting in traffic - which will be controlled by the Safety Agent.
- 4. Possibility of disruption of services (electrical, water etc.) that would have been unforeseen whilst excavating which will be repaired as soon as possible upon disruption.
- 5. Movement of heavy Construction Plant (TLB's, Tipper Trucks, Water Tanker, Excavators etc.) / machines at the areas.

Thabazimbi and Regorogile communities are thus requested to please be patient and provide the necessary cooperation during the construction phase to ensure a better service for all.
