1. Introduction

The service provider is required to assess, service, and replace air conditioning units at the municipality offices.

The objective is to ensure all air conditioning units are operating efficiently, comply with safety standards, and provide a comfortable environment for occupants.

2. Scope of Work

2.1. Assessment of Air Conditioning Units

- Conduct a detailed inspection of all air conditioning units, including split units, cassette units, and central HVAC systems.
- Identify faulty, underperforming, or inefficient units and provide a **detailed assessment report** with recommendations for repair or replacement.
- Check refrigerant levels, electrical connections, compressors, evaporators, condensers, and overall unit functionality.

2.2. Servicing of Air Conditioning Units

- Clean and replace air filters, coils, and drain lines to improve efficiency.
- Check and top up refrigerant gas where necessary.
- Inspect and service thermostats and control systems.
- Lubricate moving parts to reduce wear and tear.
- Ensure proper airflow and temperature regulation in all serviced units.
- Perform minor repairs as necessary and provide a report on any additional work required.

2.3. Replacement of Faulty Air Conditioning Units

- Remove and dispose of old or non-functional units in an environmentally responsible manner.
- Supply and install new air conditioning units as per the specifications provided.
- Ensure correct installation, including electrical wiring, piping, and mounting, in accordance with industry standards.
- Conduct system testing and commissioning to verify proper functionality.
- Provide user training on operating and maintaining the new air conditioning units.

- All servicing and replacements must adhere to **SANS (South African National Standards)** and **manufacturer guidelines**.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
